- J. CMP streetlight update-The supply shortages has been affecting CMP and they expect to have the repairs and new lights completed by the end of January 2022.

### **III. NEW BUSINESS**

Animal Control Officer, ACO- Millard Butler spoke with Noel and his concerns have been addressed. He will continue for two more years. He wants to be paid on a different schedule that aligns with the Select-board meetings. We also talked about the \$500.00 charge for the cat that was checked for rabbies. He said that he spoke with Foxcroft Veterinary and they said that they had a resident come in with it and they had been bitten by the cat. Danielle Withee said that when she tried to bring an animal there, they said that only ACOs were allowed to bring animals, so that raises the question of why they took the cat. Noel will speak with them again and see if they can come down on the charges.

Leslie Merrill said that MMA came out to inspect the sand shed for insurance purposes and found 7 of the 9 lights inside burned out and no lights on the front of the building. He also said that a cover on an electrical box near the panel is broken and missing. The board asked that the Town Office contact Joseph Gray to have him get an electrician come out and make the repairs.

Danielle Withee told the board that a few weeks ago the flag pole at the Fire Station broke and needs to be replaced. Millard Butler stated that it should be fixed sooner rather than later. The board directed the Town Office to get quotes for it to be replaced.

Tammy Buswell asked about the question of the dyed kerosene from the last meeting. She asked that it remain on the agenda for the next meeting.
